- **Carmichael Water District:**

David Merrick reported that the Water District meeting on the proposed rate increase will be held Monday December 12 at 7PM at the District offices at 7837 Fair Oaks Blvd. Two options for a rate increase were considered by CWD: a straight increase on the existing rate structure that has several classifications of customers and a new graduated rate structure that has only residential and nonresidential classifications. The CWD chose the first option.
