**Secretary's Report:** The minutes of the January 14, 2010 meeting were approved (MSP) .

**Treasurer's Report:** There was no treasurers report. The Board approved reimbursing Anne Berner \$36.54 for mailing expenses (MSP).

**Membership:** We have 133 member households.

**Guest:** Dr. Ami Bera is the only Democratic party candidate for the 3<sup>rd</sup> Congressional District that includes our neighborhood. He briefly talked about why he is running for Congress, the problems facing the country, and the public's frustrations. He answered many questions from attendees. CCNA has invited Republican incumbent Dan Lungren to attend one of our meetings.

### Old Business:

- **Fair Oaks Boulevard Cleanup in April:** Our first 2010 cleanup of Fair Oaks Boulevard will be April 11 at 9AM. Please meet us next to the Carmichael Park tennis courts.

### New Business:

- **Summer concerts in Carmichael Park:** This concert series is no longer sponsored by the Carmichael Chamber of Commerce. The Board approved (MSP)

spending \$750 to split a sponsorship with the Carmichael Colony Neighborhood Association. There will be four concerts Saturday evenings in July.

- **Effie Yeaw Nature Center:** Our local nature center barely avoided closing during the latest round of budget cuts by Sacramento County. Amanda Ness will invite a representative from the American River Natural History Association (ARNHA) to update us on the status of the Center at a future meeting.
- **Lot split at 6548 Sutter Avenue:** The Board approved (MSP) sending a letter to the Carmichael Community Planning Commission stating that we are not opposed to a proposed lot split that complies with existing zoning. The property owner requested such a letter before the March 17 Commission meeting that will consider approving the lot split.
